MINUTES OF THE MEETING REGARDING SAMPLING AND ANALYSIS OF ALL COAL SEAMS OF ALL THE COAL MINES IN INDIA BY GOVERNMENT AGENCIES & ACADEMIC INSTITUTIONS HELD ON 04.01.2017 AT CONFERENCE HALL OF COAL CONTROLLER'S ORGANIZATION, KOLKATA – 700001.

- 1. Coal Controller welcomed and wished a Happy New Year to all Participants. After introduction by the participants, he briefed about the purpose of the meeting. List of participants is enclosed as Annexure-I.
- 2. As per the review meeting taken by Secretary (coal) held at New Delhi on 21.12.2016, it has been decided that Annual Grade 2017-18 will be finalized on the basis of sample collected and analyzed by Govt. agencies or academic institutions under the supervision of CCO.
- 3. Coal Controller appraised the representatives of different Govt. agencies and academic institutions about the approximate nos. of coal samples which will have to be collected and analyzed (Company-wise). Details is as follows-

- 4. Representative of IIT, Kharagpur showed their inability to do the said job though they are having expertise but not having sufficient infrastructure to handle such voluminous job.
- 5. Representative of IIEST, Shibpur said that they can take up the said job of nearest coal company i.e. ECL if agreed by CCO.
- 6. No representative from IIT, BHU attended the meeting, however they have sent their consent through e-mail to take up the said job for NCL only.
- 7. Director, NML said that NML and CIMFR will take up the job jointly.
- 8. All Govt. agencies/Academic Institutions like CIMFR, NML, IIT (Kharagpur), IIEST (Shibpur), IIT (Guwahati) showed their inability to complete the job within 15th March'2017 if 03(three) nos. of samples for each sampling point are to be collected at an interval of not less than 7 days. After detail discussion with all OSDs and other participants, it has been decided that for this year only, two nos. of samples will be collected instead of three. Hence total number of samples will reduce from 3954 to 2636.
- 9. The complete job of sample collection, preparation and analysis must be completed within 15th March'2017.

- 10. The analysis result shall be submitted to CCO HQ and concerned CCO Regional office.
- 11. CCO Regional offices shall submit their recommendation within one week i.e. by the 22nd March, 2017 to CCO HQ.
- 12. Coal Controller advised all OSDs to follow up the matter that Annual grade Proposal 2017-18 are submitted by Coal Companies within 16th January, 2017.
- 13. Govt. agencies and Academic Institutions expressed their consent and have submitted the undertaking along with rate per sample to take up the job. Details is given below:-

- 15. Coal Controller advised CIL & SCCL representatives to provide all logistic support such as local conveyance and accommodation, etc. to the concerned agencies.
- 16. All samples will be collected in presence of regional OSD or his representative.
- 17. All samples will be coded by concerned OSD or his representative in the field ad proper record (confidential) is to be maintained.

- 18. Three packets of 500 gm. each will be prepared one for Colliery, one for Regional OSD which will be kept as referee sample and one for analysis to be taken by the agency.
- 19. Samples will be collected from dispatch points only.
- 20. Concerned Coal Company should pay 50% of total sampling and analysis cost in advance to the agency and rest 50% will have to be paid within 15 days from the date of submission of analysis result.
- 21. OSDs expressed their views and told that due to shortage of manpower it may not be possible for them to be present or depute suitable representative at each place of sampling considering the huge volume of work which is to be completed within a very short span of time.
- 22. CCO (HQ) informed that MoC has already been intimated in writing to provide manpower to each Regional Office of CCO borrowing from Coal Companies. However, a request letter from this office will also be sent to the Chairman, CIL, to provide additional Officials in each field office to complete the task in time.
- 23. The Meeting ended with Vote of Thanks to the Chair.
