The undersigned is directed to say that SCCL had submitted Progressive Mine Closure Monitoring and Audit reports of the First & Second phase conducted by CSIR, NEERI, Nagpur and IIST, Shibpur regarding reimbursement of claims under progressive Mine closure Plan of 4 Mines of SCCL as mentioned in Annexure –I for an amount of **Rs. 17,72,88,958/- (Seventeen Crore Seventy-Two Lakh Eighty-Eight Thousand Nine Hundred Fifty-Eight Rupees only)**. After scrutiny of documents submitted by SCCL and inspection report submitted by OSD, CCO, Kothagudem, The Technical Committee of CCO (HQ), had recommended for reimbursement of **Rs. 9,35,64,488/- (Nine Crore Thirty-Five Lakh Sixty Four Thousand Four Hundred And Eighty Eight Rupees only)** for the said projects. Now the Amounting of **Rs. 9,35,64,488/- (Nine Crore Thirty-Five Lakh Sixty-Four Thousand Four Hundred And Eighty Eight Rupees only)** is to be released as per the new guidelines issued by M/o Coal dated 29th May 2020.
