Notice

The undersigned is directed to say that WCL had submitted Progressive Mine Closure Monitoring and Audit reports of the first phase conducted by 3rd Party Audit Agency regarding reimbursement of claims under progressive Mine closure Plan of 11 number of Mines of WCL as mentioned in Annexure –I for an amount of Rs. 87,17,02,690/- (Eighty Seven Crore Seventeen Lakh Two Thousand Six Hundred Ninety only) from Mine Closure Escrow fund of those mines as per Mine Closure Plan Guidelines. 50% of the eligible amount Rs. 32,09,46,080/- (Thirty Two Crore Nine Lakh Forty Six Thousand Eighty only) has already been released by Coal Controller to WCL from ESCROW Accounts as per directive of M/o Coal. After scrutiny of documents submitted by WCL and inspection report submitted by OSD, CCO, Nagpur, the Technical Committee of CCO (HQ), Kolkata had recommended for reimbursement of Rs. 64,18,92,156/- (Sixty Four Crore Eighteen Lakh Ninety Two Thousand One Hundred Fifty Six only) for the said projects. Balance amount of Rs. 32,09,46,076/- (Thirty Two Crore Nine Lakh Forty Six Thousand Seventy Six only) is to be released as per the new guidelines issued by M/o Coal dated 29th may 2020.

Before release of fund, it is brought to the notice that if any comments/views by any stake holder of Mines arise, they are invited to submit the same to the Office of the Coal Controller (coalcont-wb@nic.in, cco.mcps-coal@gov.in) within **15 days positively** from the date of issue of the said notice after which no submission will be accepted.
