The undersigned is directed to say that BCCL, had submitted Progressive Mine Closure Monitoring and Audit reports of the First Phase conducted by IEST, Shibpur regarding reimbursement of claim under progressive Mine closure Plan of 02 Mines of BCCL as mentioned in Annexure -I for an amount of **Rs.5,85,98,870/- (Five Crore Eighty-Five Lakh Ninety-Eight Thousand Eight Hundred and Seventy Rupees only)**. After scrutiny of documents submitted by BCCL and inspection reports submitted by OSD, CCO, Dhanbad, the Technical Committee of CCO (HQ), had recommended for reimbursement of **Rs.5,65,27,679/-(Five Crore Sixty Five Lakh Twenty Seven Thousand Six Hundred And Seventy Nine Rupees only)** for the said project. An Amount of **Rs.2,92,99,936/-(Two Crore Ninety Two Lakh Ninety Nine Thousand Nine Hundred and Thirty Six Rupees Only)** was released on dated 24.06.2020 & 09.07.2020 the balance Amount of **Rs.2,72,27,743/-(One Crore Seventy Two Lakh Twenty Seven Thousand Seven Hundred And Forty Three Rupees only)** is to be released as per the new guideline issued by M/o Coal dated 29th May 2020.

Before release of fund, it is brought to the notice that if any comments/views by any stake holder of Mines arise, they are invited to submit the same to the Office of the Coal Controller (coalcont-wb@nic.in, cco.mcps-coal@gov.in) within **15 days positively** from the date of issue of the said notice after which no submission will be accepted.
