After scrutiny of document submitted by CCL Ranchi and inspection report submitted by **OSD, CCO, Ranchi**, the Technical Committee of CCO (IIQ), had recommended for reimbursement of **Rs. 22,70,965/-(Twenty Two Lakh Seventy Thousand Nine Hundred and Sixty Five Rupees only)** for the said project.
