The undersigned is directed to say that MCL, Sambalpur had submitted Progressive Mine Closure Monitoring and Audit reports of the First & Second Phase conducted by CMPDIL, Bhubaneswar regarding reimbursement of claims under progressive Mine closure Plan of 02 Mines of MCL as mentioned in Annexure -I for an amount of **Rs.24,85,63,000/- (Twenty-Four Crore Eighty-Five Lakh Sixty-Three Thousand Rupees only)**. After scrutiny of document submitted by MCL and inspection report submitted by OSD, CCO, Sambalpur, the Technical Committee of CCO (HQ), had recommended for reimbursement of **Rs. 24,63,05,332/- (Twenty-Four Crore Sixty-Three Lakh Five Thousand Three Hundred and Thirty-Two Rupees only)** for the said project. An Amount of **Rs. 22,36,41,500/- (Twenty-two Crore thirty-six Lakh Forty-One Thousand Five Hundred Rupees Only)** was released for one Mine on dated 20.04.2020 the balance Amount of **Rs. 2,26,63,832/- (Two Crore Twenty-Six Lakh Sixty-Three Thousand Eight Hundred and Thirty-Two Rupees Only)** is to be released as per the new guideline issued by M/o Coal dated 29th May 2020.

Before release of fund, it is brought to the notice that if any comments/views by any stake holder of Mines arise, they are invited to submit the same to the Office of the Coal Controller (coalcont-wb@nic.in, cco.mcps-coal@gov.in) within **15 days positively** from the date of issue of the said notice after which no submission will be accepted.
