Notice

The undersigned is directed to say that WCL had submitted Final Mine Closure Monitoring and Audit reports of the Final mine closure claims conducted by CSIR, NEERI, Nagpur, regarding reimbursement of claims under Final Mine closure Plan of 01 Mine of WCL as mentioned in Annexure –I for reimbursement of existing amount in the escrow account at the end of final mine closure. After scrutiny of documents submitted by WCL and inspection report submitted by OSD, CCO, Nagpur, the Technical Committee of CCO (HQ), had recommended for reimbursement of Rs.12,36,76,750/- (Twelve Crore Thirty-six Lakhs Seventy-Six Thousand Seven Hundred Fifty Rupees Only) for the said project. As per the approval of Competent Authority, I am directed that an amount of Rs.12,36,76,750/- (Twelve Crore Thirty-six Lakhs Seventy-Six Thousand Seven Hundred Fifty Rupees Only) will be released as per the new guidelines issued by M/o Coal dated 31<sup>st</sup> January 2025.

**The remaining 10% of the Escrow fund shall be kept on hold to be utilized towards Just Transition provisions, as envisaged under the aforesaid guidelines, once the detailed modalities are issued.**

Before release of fund, it is brought to the notice that if any comments/views by any stake holder of Mines arise, they are invited to submit the same to the Office of the Coal Controller ([coalcont-wb@nic.in](mailto:coalcont-wb@nic.in), [cco.mcps-coal@gov.in](mailto:cco.mcps-coal@gov.in) ) within **15 days positively** from the date of issue of the said notice after which no submission will be accepted.
