The undersigned is directed to say that BCCL, had submitted Progressive Mine Closure Monitoring and Audit reports of the First Phase conducted by IEST, Shibpur regarding reimbursement of claim under progressive Mine closure Plan of 02 Mines of BCCL as mentioned in Annexure –I for an amount of Rs. 4,30,44,314/- (Four Crore Thirty Lakh Forty Four Thousand Three Hundred and Fourteen Rupees only). After scrutiny of document submitted by BCCL and inspection report submitted by OSD, CCO, Dhanbad, the Technical Committee of CCO (HQ), had recommended for reimbursement of Rs. 3,69,58,031/- (Three Crore Sixty Nine Lakh Fifty Eight Thousand And Thirty One Rupees only) for the said project. An Amount of Rs. 2,15,22,158/- (Two Crore Fifteen Lakh Twenty Two Thousand One Hundred and Fifty Eight Rupees Only) was released on dated 24.06.2020 & 09.07.2020 the balance **Amount of Rs. 1,54,35,873/- (One Crore Fifty Four Lakh Thirty Five Thousand Eight Hundred And Seventy Three Rupees only)** is to be released as per the new guideline issued by M/o Coal dated 29th May 2020.

Before release of fund, it is brought to the notice that if any comments/views by any stake holder of Mines arise, they are invited to submit the same to the Office of the Coal Controller (coalcont-wb@nic.in, cco.mcps-coal@gov.in) within 15 days positively from the date of issue of the said notice after which no submission will be accepted.
